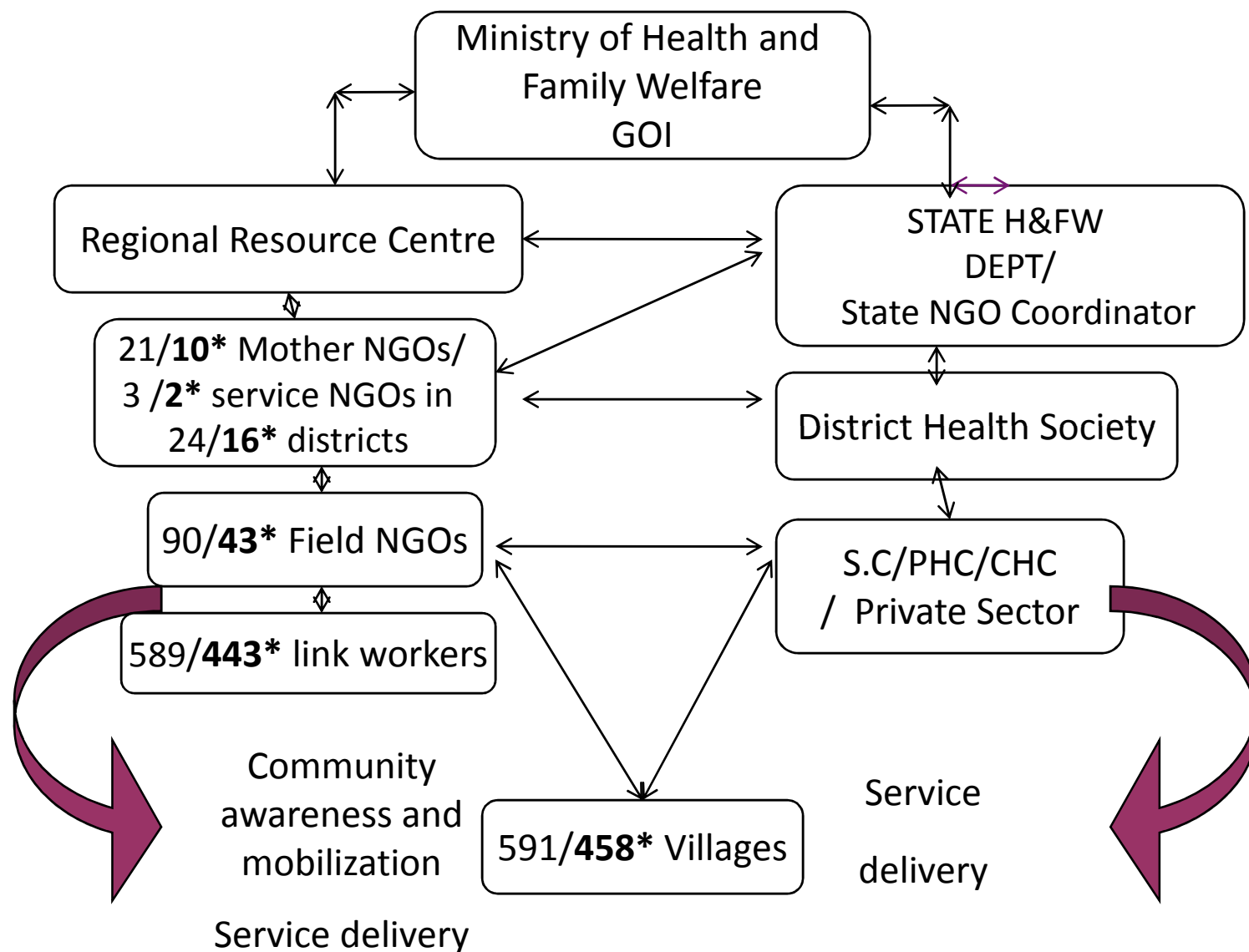
MNGO Scheme



- Mother NGO (MNGO) scheme was initiated in 1998 by the Government of India to solicit civil society involvement in Reproductive and Child Health (RCH) Programme.
- The scheme focuses on addressing the unmet need of RCH services in underserved areas by involving NGOs.
- One of the largest initiatives in India to involve NGOs in delivering RCH services. NGOs are accredited by the health department for Community Mobilization and strengthening of services.

MNGO /SNGO Status in Gujarat (2006 onwards..)

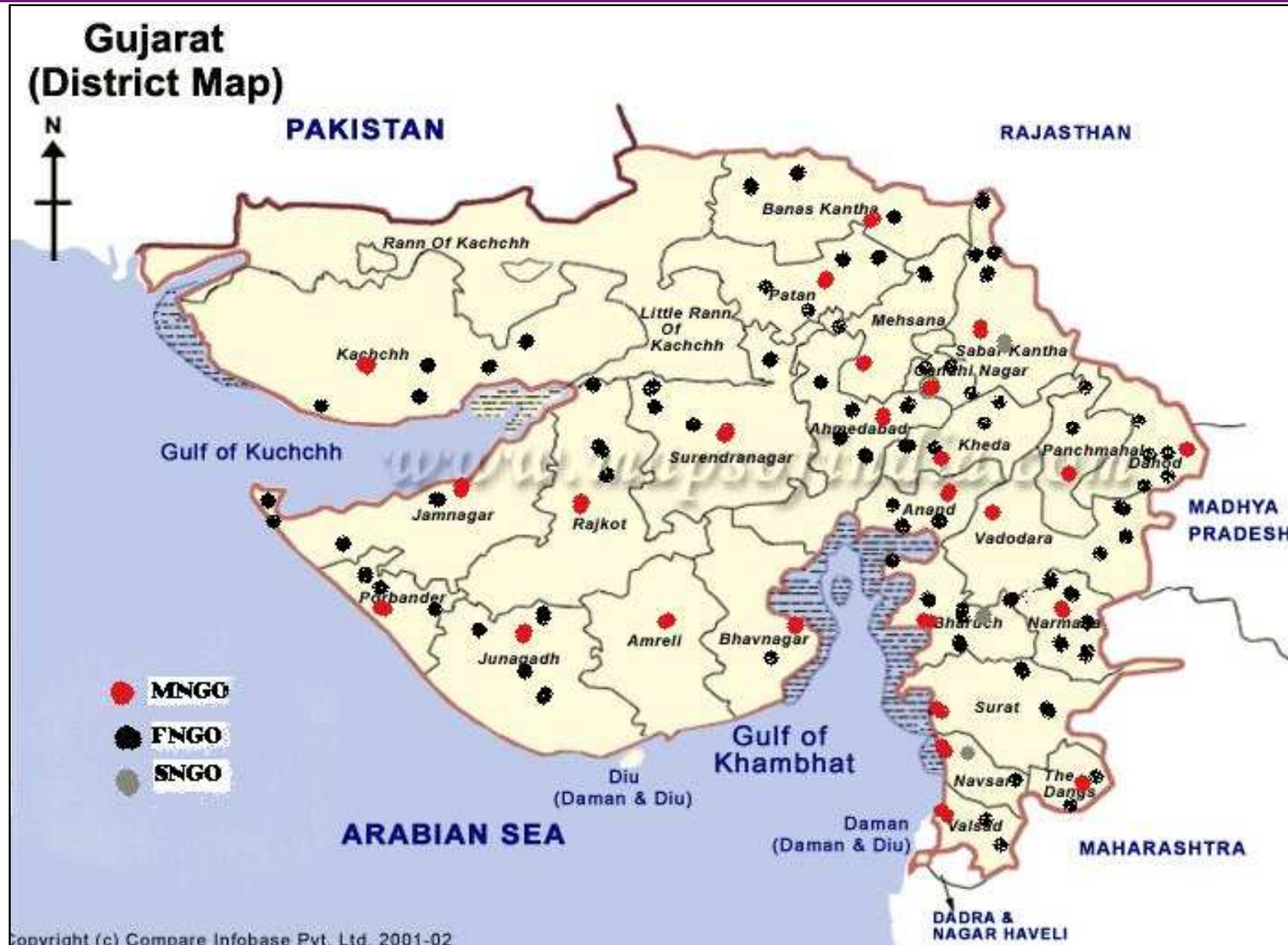

Role of Field NGOs



- 3-4 NGOs identified by the District Health Society
- Varied experience on Health issues
- Covers approx. 8000 to 12000 population
- Appoints Village health Worker per 1000 population/ per village
- Project Duration- 3 years
- Annual Budget- Rs. 3-4 lacs
- Total budget- Rs. 9-12 lacs

Role of Mother NGOs



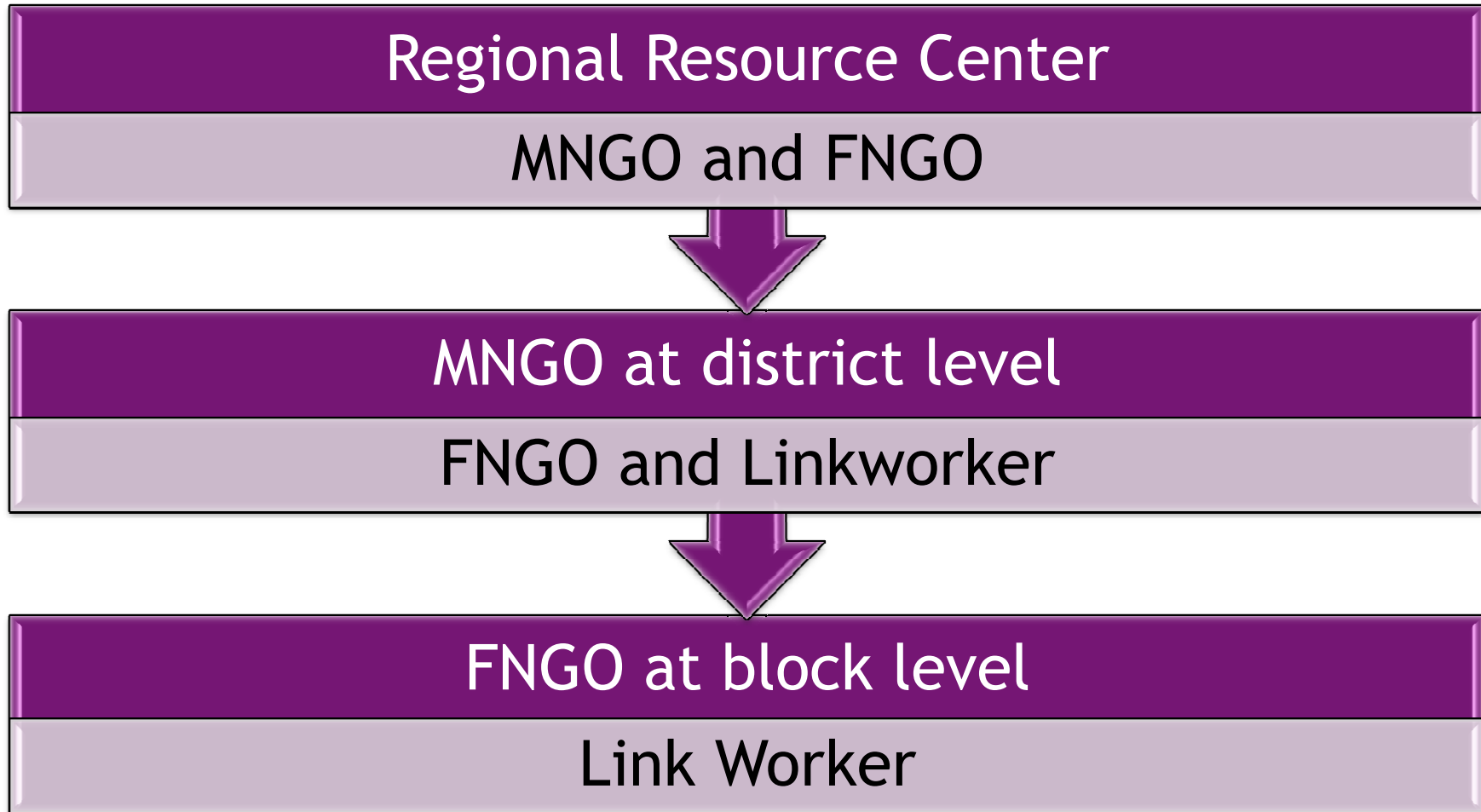
- Acts as a district nodal NGO
- Varied experience on Health Issues
- Accountable to the District and State Department of Health and Family Welfare ,FNGOs and RRC
- Provides Technical and managerial Capacity building support to FNGOs and Mentoring and Supportive Supervision of FNGOs
- Project Period- 3 years
- Annual Budget Rs.3,00,000/-
- Total budget 9,00,000/-

CHETNA Regional Resource Centre (CRRC)

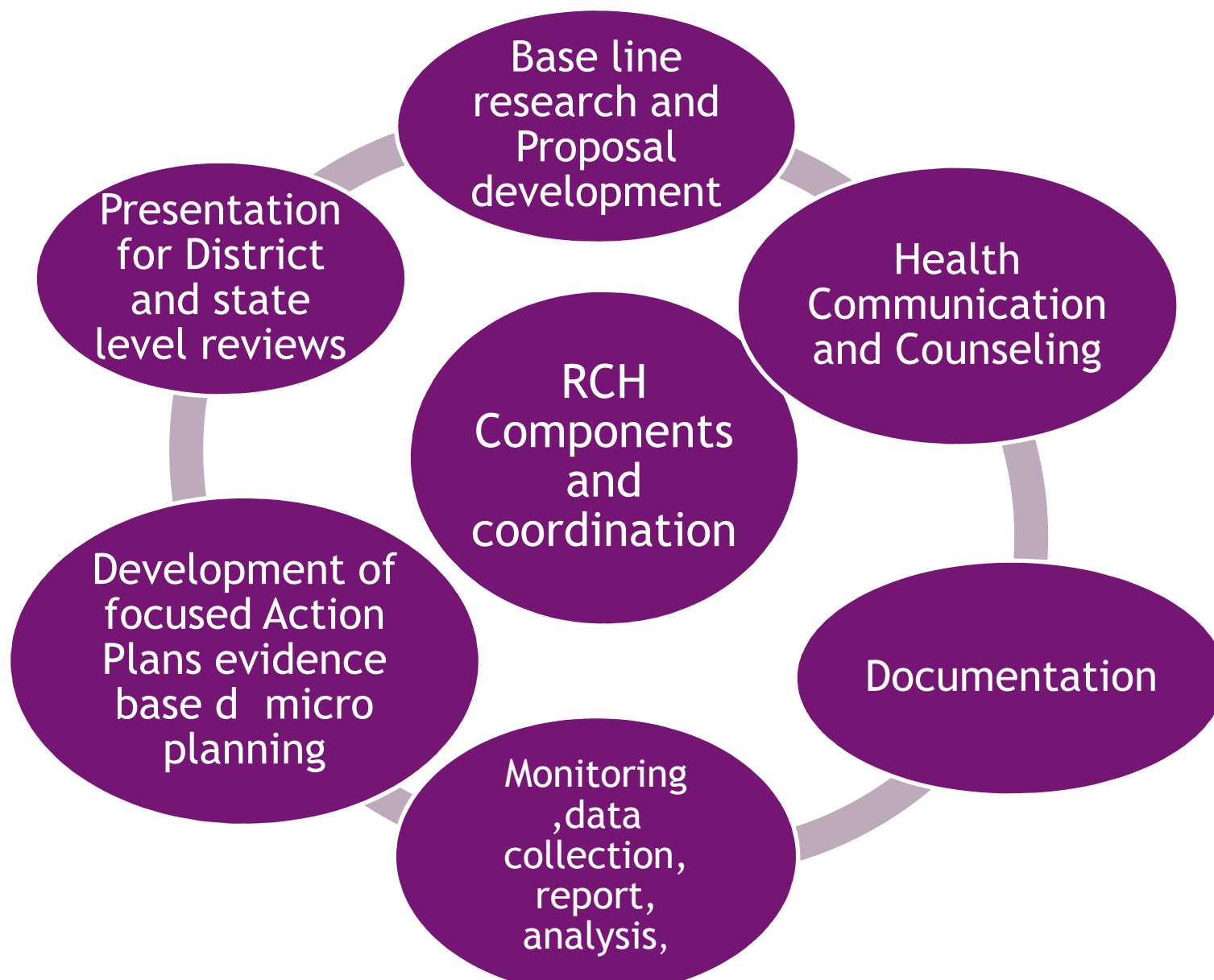


- Identified and mentored by the Ministry of Health and Family Welfare, GOI and the Department of Health and Family Welfare, GOG
- Provides technical support for effective programme management, including monitoring and evaluation to MNGOs/Service NGOs.
- Coordinates with the Ministry of Health and Family Welfare, GOI State Health and Family Welfare Department and the Mother/Service NGOs
- Contributes in Performance monitoring and evaluation of MNGOs
- Project Period- Annual
- Annual budget : 25 lacs

- State level Orientation workshop for 74 Coordinators in October 2011 followed by two Counselling trainings for 74 coordinators in November 2011.

Basic Concepts Of Monitoring And Evaluation- for 24 MNGO/SNGO coordinators - September 2008

- Field level support to 21 MNGOs for training of FNGOs/data operators and Link workers and installation of HMIS system- October-December 2008
- 14 Refresher trainings of 10 MNGOs/ 28 FNGOs and One to one hand holding trainings of 11 MNGO coordinators and 28 FNGO coordinators in 2009
- 1 Refresher trainings of 3MNGOs and One to one hand holding trainings of 2 MNGO coordinators in 2010
- 2 Refresher trainings of 37 coordinators , data entry operators of 10 MNGOs/ 23 FNGOs and One to one hand holding trainings of 5 MNGO coordinators in 2011

Ongoing verification, rectification and feedback on quarterly and annual reports.

Capacity building on Data Analysis, presentation skills



A total of 8 trainings were organized during 2009-2012. A total of 20 coordinators from 20 MNGOs/3 SNGOs and 35 FNGOs participated.

- Supported 10 MNGO/ 15 FNGO / 3 SNGO coordinator to analyse their achievement data and contributed in their presentation. April-December, 2009
- Supported 17 MNGO /20 FNGO/ 3 SNGO coordinator to analyse their achievement data and contributed in their presentation. Jan.-December, 2010
- Provided One to one hand holding trainings of 3 MNGO coordinator and Feedback on the presentation of 3 MNGOs were given. April-December, 2011
- Reviewed and provided technical inputs on the presentation of achievements of 1 MNGO and guided the newly appointed coordinator. Inputs were given to 2 MNGO to develop a presentation of the work done. Jan – March-2012

Capacity building to develop Action plans



A total of 11 training were organized to support the MNGOs / SNGOs to develop focused action plans

- Organised 4 trainings on Proposal Development for 4 MNGO coordinators , April -June 2008.
- Organised 4 workshops region wise on Focused Action Plan for MNGO/ FNGOs , Jan –March,2009
- Provided support for 4 MNGO to developing action plan, April –December 2010
- Guided 6 MNGO to develop village wise action plans. April-September 2011
- 3 Planning meeting for orientation of 13 MNGOs/41 FNGOs/2 SNGOs. July-September 2012

Review and Evaluation



Review of efforts and achievements by state, district departments and CRRC during November 2009- June 2010

End project review of 14 MNGOs completing three years of project implementation has been conducted by the Department of Health and Family Welfare, Government of Gujarat and CHETNA-RRC during September-October 2010.

Five Regional Reviews of 19 MNGOs/3 SNGOs has been conducted by the Regional, District and Block Health Officials of the Department of Health and Family Welfare, Government of Gujarat in December 2010.

State level Review and planning meeting was held in May 2012

Status Initiation of scheme in UTs Status
